Assignment for Academic Credit

Course Title: Meaningful Observation of Preschool Children

Dept. & Course #: ECS 906 (Academic Credit)

Description:

This one day training course concentrates on one component of the Desired Results training already approved for academic credit. The component it covers is the observation of young children. This training is offered for teachers of childcare agencies in state-funded and other programs. One unit of academic credit will be offered to students based on their attendance in class and the successful completion of the assignment. Students must register using the attached form. Students must also sign in and out to verify their attendance at the training.

The class will meet in person once for eight hours. Students will then be given an assignment that they will take back to their classrooms. The remaining seven contact hours will include feedback on the assignment and the assignment itself. All contact for the remaining hours will be via phone, email, or fax.

Written Assignment:

Each student is required to:

1. Read the DRDP (2015) and the DRDP (2015) User's Guide.
2. Create a portfolio for a single child which includes anecdotal notes, photos with captions, work samples with captions, observations from parents, family, and other staff, and/or journal entries or running records over time. This documentation could be copied, but be organized to support completing the DRDP. All evidence should be gathered over 60 calendar days and be mailed to the address below within 65 days of the training you attended. Mail the assignment to: DR Fee Based Training, 333 N.
