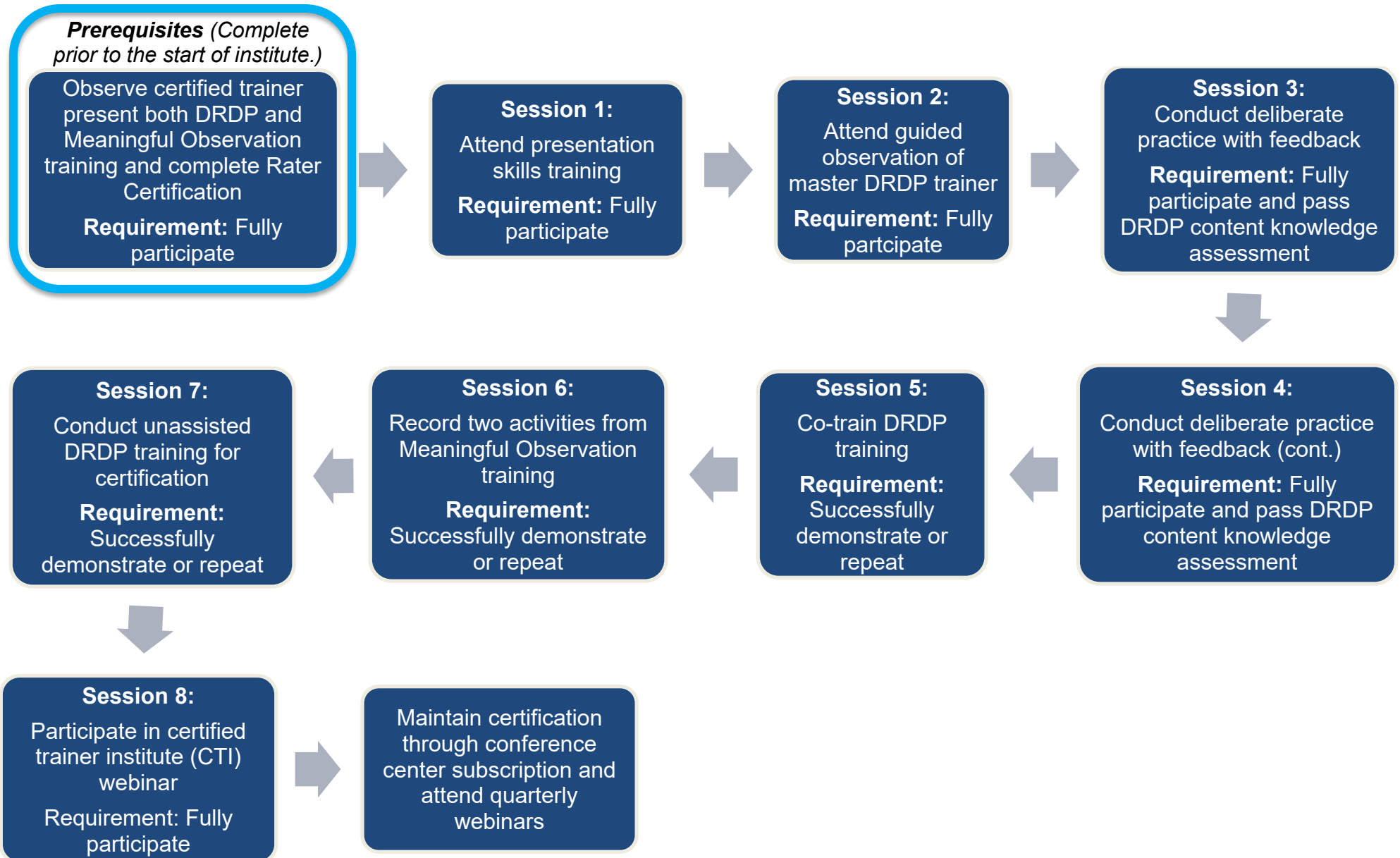

DRDP Virtual Certified Trainer Institute (CTI)—Two Training Certification Process Graphic

Prerequisite – Observe a master trainer present the DRDP and Meaningful Observation training and complete Rater Certification California Early Childhood Online (CECO). Prospective trainer fully engages as a participant. *Option—Complete all CECO five DRDP modules and complete Rater Certification.

Session 1 – Attend presentation skills training presented by a master coach and master trainer. Prospective trainers learn and practice strategies for presenting, keeping the audience engaged, and learning from the master coach. (7 hours)

Session 2 – Attend guided observation of master DRDP trainer presenting the DRDP training. Prospective trainers observe master DRDP trainer while the master coach points out strategies and techniques learned in presentation skills training. (9 hours over two days)

Session 3 – Conduct guided study and deliberate practice with feedback. Prospective trainers reflect on the training skills and content observed and study sections of the DRDP training with peers and the master coach. Prospective trainers practice content from the DRDP training with their peers and receive immediate feedback from peers, the master DRDP trainer, and the master coach. The prospective trainer will receive written and oral feedback and notification if they can proceed in the process or need to repeat any or all of the sessions. At this time, prospective trainers complete a DRDP content knowledge assessment. (4.5 hours)

Session 4 – Conduct deliberate practice with feedback (continued). Prospective trainers practice content from the DRDP training with their peers and receive immediate feedback from peers, the master DRDP trainer, and the master coach. The prospective trainer will receive written and oral feedback and notification if they can proceed in the process or need to repeat any or all of the sessions. (4.5 hours)

Session 5 – The prospective trainer will record themselves conducting two activities from the Meaningful Observation training. The master trainer will provide written detailed feedback following the training/recording. An optional virtual planning call will occur prior to the training. The prospective trainer will receive notification if they can proceed in the process or need to repeat co-training of Meaningful Observation training with the master trainer.

Session 6 – Co-train DRDP virtual training. The prospective trainer will lead a DRDP training with the master trainer ready to intervene. This will be facilitated either with the master trainer or another prospective trainer. The master trainer will provide feedback throughout the training and will give detailed feedback following the training. An optional virtual planning call will occur prior to the training. The prospective trainer will receive notification if they can proceed in the process or need to repeat co-training of DRDP training with the master trainer. (The prospective trainer will plan teacher training at their agency.)

Session 7 – Conduct unassisted DRDP virtual training for certification. The prospective trainer will lead a DRDP training with no intervention from the master trainer. The master trainer will provide detailed feedback at the end of the training. An optional virtual planning call will occur prior to training. The prospective trainer will receive notification if they are certified or need to repeat the solo certification training with the master trainer.

Session 8 – Participate in Desired Results Certified Trainer Institute webinar. Certified trainers will participate in a webinar to gain access to the Desired Results Conference Center – a resource center for ongoing trainer support. Certification is then complete, and the participant may train within their agency or consortium.

Maintain certification through conference center subscription and attending quarterly webinars. To continue to maintain certification, certified trainers must attend quarterly webinars scheduled and provided by a master trainer and must continue their conference center subscription.
